Erin Christensen read the minutes; they were approved as read.

Annie Carlin gave the financial report: at the end of March - dollar acct: \$ 23,176.25 USD, peso acct: NM \$29,706.66 pesos.

Annual assessments for 2015 have been made on 29 houses; 2 are partial payments. None of the houses used as rentals have yet been paid. Mr. Echeverria, our accountant, has suggested to Annie that for our own accounting, a semi-annual rather than quarterly report is sufficient, since we have few variable expenses. She reports the monthly peso and dollar balances at our board of directors meetings, which are posted on the website monthly. It was decided that hereafter, the complete accounting report will be made semi-annually.

Old business:

- 1. Richard had La Hacienda's water tested, it is potable.
- 2. Ed reported on the ADM internet system -Pablo is still working on it, city is still having trouble with fiber optics. It works pretty well right now.
- 3. Traffic issues: The cul-de-sac above the beach palapas is getting damaged. Vehicles are being driven through there from the houses to the beach, over the beach wall. A couple of wire fences can prevent this without restricting foot traffic to the beach. Some wire was left over from previous fencing projects. Also, the road next to Anna's new house (the former Moore residence) is still being damaged by ATV's. We will make signs for where ATV access will benext to condos and at entrance. Erin made a motion for the architectural committee to do a survey to determine what can be done with wire fences, Annie seconded, passed.
- 4. Entrance gate: it will be closed at night this quarter. We will notify residents before this happens.
